The planning commission is subject to the Michigan Open Meetings Act and Freedom of Information Act.

The township board may remove a member of the planning commission for misfeasance, malfeasance or nonfeasance in office upon written charges and after a public hearing. (MCL 125.3815)

Unless the township board, by ordinance, defines conflict of interest for the purposes of the planning commission, the planning commission must do so in its bylaws. Before casting a vote on a matter on which a member may reasonably be considered to have a conflict of interest, the member must disclose the potential conflict of interest to the planning commission. The member is disqualified from voting on the matter if so provided by the bylaws or by a majority vote of the remaining members of the planning commission. Failure of a member to disclose a potential conflict of interest constitutes malfeasance in office. (MCL 125,3815)

The planning commission elects from its membership a chairperson, a secretary and other officers as it determines necessary for one year. The ex officio member cannot serve as chairperson (MCL 125.3817).

The township planning commission is required to meet at least four times per year. It determines the time and place of any and all of its meetings, adopting by resolution its schedule of regular meetings. (MCI. 125,3821)

A quorum of the planning commission must be present at a meeting to be able to do business. A quorum is three of a five-member commission, four of a seven-member commission, and five of a ninemember commission.

Unless the bylaws provide otherwise, a special meeting of the planning commission may be called by the chairperson or by two other members, upon written request to the secretary. Unless the bylaws provide otherwise, the secretary shall send written notice of a special meeting to planning commission members not less than 48 hours before the meeting. (MCL 125,3821)
